Affidavit of Carlos Adrian Caceres Carvajal

My name is Carlos Adrian Caceres Carvajal. I was born in Colombia on February 3rd, 2003, and to the best of my knowledge, my father, Anibal Caceres Valverde, abandoned my mother, Yulibeth Carvajal Riobo, during her pregnancy, leaving her to bear the responsibility of raising me alone with very little financial help. I lived with my mother and her partner as a child. He would humiliate, threaten, and beat me.

I had minimal contact with my father. When I was 7 years old, he offered to take me on a vacation, which turned out to be a work trip in Barranquilla, Colombia. He left me alone in a hotel room for a whole day where I was sexually abused by a stranger. My father ignored the whole situation and completely cut contact with me after that.

Despite my father's legal obligations to support me, he has never contributed to my upbringing or provided enough financial assistance for my well-being, education, or basic needs. This lack of financial support has been a significant burden on my family. Due to the financial strain and responsibilities my mother faced, she compelled me to leave school and move out at 15 and start working to contribute to the family's income. This decision deprived me of my right to an education and the opportunities it could have provided for my future.

Throughout my adolescence and into adulthood, I have faced numerous challenges and hardships resulting from the absence of my father, the unstable environment at my mother's house and my early withdrawal from formal education. As a result, I have had limited career opportunities, earning potential, and personal growth prospects. I worked on cattle farms in El Catatumbo North Santander, where I suffered from labor exploitation and was constantly threatened by guerrillas.

The emotional toll of growing up without a father's presence and support has been profound. As well as the fear I experienced being forced out of my home by my mother. I have experienced feelings of abandonment, low self-esteem, and a constant yearning for a father figure in my life, which has affected my emotional well-being and relationships.
